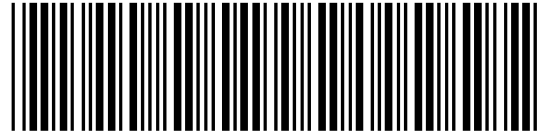

If the contributions exceed the refund due, no contributions will be made or deducted from your refund.
